

## **2019 Adelaide 500 Presale Conditions of Sale**

1. The 500 Club is a presale ticket offer for the Adelaide 500 (“**Event**”) in 2019, presented by the South Australian Tourism Commission (“**SATC**”).
2. Patrons who held 4-day grandstand, Platform 9 or reserved Senna Platform tickets for the 2018 Event may re-book for the 2019 Event between 9:00am (ACST) Friday, 1 June 2018 and 11:59pm (ACST) Sunday, 8 July 2018.
3. Patrons who did not hold tickets for the 2018 Event may register for 4-day grandstand tickets for the 2019 Event between 8:00am (ACST) Friday, 1 June 2018 and 11:59pm (ACST) Sunday, 8 July 2018 at <https://www.adelaide500.com.au/500Club>.
4. SATC’s ticket sales agent, Ticketmaster Australasia Pty Ltd (“**Ticketmaster**”), will process bookings in order of receipt.
5. Patrons who held 4-day grandstand, Platform 9 or reserved Senna Platform tickets for the 2018 Event must re-book and commence payment for tickets for the 2019 Event by 11:59pm (ACST) Sunday, 8 July 2018.
6. All tickets not re-booked by 11:59pm (ACST) Sunday, 8 July 2018 will be available to new 500 Club members. Any remaining seats will be released for general purchase prior to the 2019 Event and the presale ticket offer will not apply.
7. Family seating tickets include 4-day entry for two (2) adults and two (2) children (14 years of age and under).
8. Accessible (wheelchair) seating includes two (2) tickets (one (1) accessible (wheelchair) seating ticket and one (1) attendant care support ticket) for the price of one (1) ticket at Chicane Grandstand, Hairpin Grandstand or General Admission.
9. Companion Card seating includes two (2) tickets (one (1) Companion Card holder ticket and one (1) attendant care support ticket) for the price of one (1) at Hairpin Grandstand or Pit Entry Grandstand.
10. Presale tickets in hard card and lanyard format will be posted prior to the 2019 Event.
11. Tickets paid for using Ticketmaster’s Installed Payment Plan will be charged in three (3) instalments as specified in the schedule below:
  - i. A first instalment of 20% of the total booking value plus a \$13 transaction and processing fee will be charged at the time of booking;
  - ii. A second instalment of 40% will be charged on the Monday, 6 August 2018;
  - iii. A third instalment of 40% will be charged on Thursday, 3 September 2018;
12. No tickets will be made available until full payment has been received.

13. Customers must ensure sufficient clear funds are available in the nominated account on scheduled drawing dates. SATC will not be liable for any fees levied to a customer by its financial institution.
14. If full payment for tickets is not received, tickets will be made available in proportion to the value of payments received. Tickets not paid for will be made available for general purchase prior to the 2019 Event and SATC is not required to provide any refund.
15. All tickets are valid for the date or period as indicated on the tickets.
16. SATC reserves the right to determine actual and final location of seating, viewing areas and other conveniences and attractions without notice.
